Opening Business

Changes, Additions and Adoptions of the Agenda

Susan requested the addition of two items under New Business: Item B. Salaries and Negotiations and Item C. Paraeducator Salary Schedule. Sandy Chapman made a motion to approve the agenda as amended. Susan Rader seconded the motion. It passed with a 5-0 vote.

New Business

Accept Paraeducator Agreements

Belinda Rehmer made a motion to approve the paraeducator agreements for Debra Hall, Life Skills Class, EES and Katie O'Brien, BHS. Chad Christie seconded the motion. It passed with a 6-0 vote.

Salary and Negotiations

Baldwin District will be voting Monday, December 17th on their negotiated agreement. Once they have approved their salary schedule, then the Cooperative will be able to issue 2012-2013 contracts to certified staff. The new contract amounts will take effect January 1, 2013.

Mike Kelso made a motion to implement raises for the Cooperative Administrator, Principal at WEBS and Office Staff based on the average of the 3 districts percentage for administrative staff. Belinda Rehmer seconded the motion. It passed with a 6-0 vote.

Paraeducator Salary Schedule

Placement on the paraeducator salary schedule is now based on whether or not a person has a college degree. Board members have requested a survey of the Cooperative paraeducators to see how many have college degrees. Board discussion of this matter will continue at a later date once survey results have been received.

- Susan discussed student attendance issues at the WEBS program
