Opening Business

Changes, Additions and Adoptions of the Agenda

Susan Christensen, added School for the Blind and Spanish Interpreter, under Item F. Contracts for Services. Sandy Chapman made a motion to add the noted items to the agenda. Mike Kelso seconded the motion. It passed with a 6-0 vote.

Approval of the August Board Meeting Minutes

Belinda Rehmer made a motion to accept the minutes of the August board meeting. Susan Rader seconded the motion. It passed with a 6-0 vote.

Approval of Financial Reports and Disbursements

Sandy Chapman made a motion to accept the financial reports and disbursements as presented. Chad Christie seconded the motion. It passed with a 6-0 vote.

Accept Paraeducator Resignations

Susan Rader made a motion to accept the resignations of Christa Kidd, EMS paraeducator and Trenda Garrett, B-PC paraeducator. Sandy Chapman seconded the motion. It passed with a 6-0 vote.

Cooperative Contribution toward Health Premiums

Susan Rader made a motion for the Cooperative to contribute an additional \$20/month toward health premiums for 2012-2013. Sandy Chapman seconded the motion. It passed with a 6-0 vote.

Paraeducator Substitute Rate

Sandy Chapman made a motion to establish the daily paraeducator substitute rate at \$64.05 per day. Chad Christie seconded the motion. It passed with a 6-0 vote.

Gifted Test Out Policy

Gifted Test Out Policy

As required by K.A.R. 91-40-3 (g), (h), *all* gifted *students* shall be allowed the opportunity to test out of, and receive credit for, required and/or prerequisite courses. If the student wishes to test out of a class having a prerequisite, the student shall make a written request to the instructor for the classes he/she expects to receive credit for. Within two weeks from the time the written request is received, the teacher or subject area department representative will design a test or project, which reflects the basic goals and objectives of the course content. In order to received credit and/or be eligible for another course, the student must demonstrate 90% mastery of the material.

In the event that this level of mastery is demonstrated, the student shall receive credit and the IEP committee shall determine an alternative course of study. In the event that the student wishes to work at an accelerated pace, the gifted facilitator and a subject area department representative shall work together to design an alternative.

Change To:

According to Kansas Regulation K.A.R. 91-40-3 (g)(h)

(g) Each gifted child shall be permitted to test out of, or work at an individual rate, and receive credit for required or prerequisite courses, or both, at all grade levels, if so specified in that child's individualized education program.

(h) Any gifted child may receive credit for college study at the college of high school level, or both. If a gifted child chooses to receive college credit, however, the student shall be responsible for the college tuition costs.

Sandy Chapman made a motion to change the gifted test out policy to the one presented. Belinda Rehmer seconded the motion. It passed by a 6-0 vote.

Contracts for Services

Spanish Interpreter

Belinda Rehmer made a motion to approve the contract for a Spanish Interpreter. Susan Rader seconded the motion. It passed with a 6-0 vote.

School for the Blind

Mike Kelso made a motion to approve the contract with the School for the Blind for services. Chad Christie seconded the motion. It passed with a 6-0 vote.

Quantum Contract

Director's Reports

- Susan and the Superintendents have been discussing transferring the hiring of paraeducators to the school building Principals.
- The Baldwin Education Foundation awarded 22 teachers grants for 2012-2013 Innovative Project Grants. Eight teachers were special education teachers awarded a total of \$2,029.
